## OFFICIAL RULES & REGULATIONS

Each Junior Miss California International entrant must be a minimum of 11 years of age and no older than 13 years of age by the date of the State Pageant.

Contestant vying for the state title must be a U.S. Citizen and at least a six month resident of California.

Entrants must be born female, single, never married, nor given birth to a child.

Entrants must be of good health and moral character.

All decisions as to the eligibility shall be determined by Peterson Productions, Inc, and the Junior Miss California International committee.

All decisions of the judges are final and irrevocable.

Any contestant and/or family member or guest showing unsportsmanlike behavior will lead to the disqualification of the contestant. No refunds will be given.

If for any reason a winner is disqualified, or elects not to participate, her title and all awards including crown and banner, trophy and prizes will be returned to the State Office and given to the next choice of the judges. I understand that the contestant whose title is relinquished or who is disqualified shall be responsible for any and all court costs, and attorney's fees incurred by Peterson Productions, Inc. in an effort to have the aforementioned property returned to the state office.

Entrants hereby agree to release unconditionally and forever, any claim against Peterson Productions, Inc and/or the Junior Miss California International Pageant, its officers, directors, employees, agents, subsidiaries, which they may have, by virtue of their participation in this pageant or any use of their name, likeness, voice and/or biography in connection with this pageant, including use in promotional and advertising material.

Peterson Productions, Inc. and the Junior Miss California International Pageant reserve the right to change the date and location of the state pageant.

Employees of Peterson Productions, Inc. and members of their immediate families are not eligible to participate in the competition.

Entrants agree that if they enter a city or county preliminary and succeed to a state level title they will not participate in any pageants during the time that they hold either of those titles, unless authorized in writing by Peterson Productions, Inc. and the Junior Miss California International Pageant.

Contestants and their parents/guardians agree to hold harmless all persons affiliated with Peterson Productions Inc, and the Junior Miss California International Pageant in case of any loss or injury occurring during, or in travel to and/or from this event.

Recipient of the title Junior Miss California International 2010 promises to promote the pageant by making a minimum of 1 personal appearance per month. Titleholder further promises to make no personal appearances or appear in any advertising and/or publications without permission from the Executive State Director, Mr. Eddie Peterson.

Junior Miss California International 2010 promises to return to the 2011 Junior Miss California International Pageant, in crown and banner, to crown her successor.

Local representatives agree that they accept their titles with the understanding that they will compete at the next level and assume all responsibility for payment of fees.

A Contestant could be selected to participate as a delegate "at large" if there is no competition for her area.

Crowns and banners remain the property of Peterson Productions, Inc. and the Junior Miss California International Pageant until after the 2011 state pageant is concluded. Any delegate who defaults on her contract must return all prizes and awards including her crown and banner to the state office in the condition in which it was received.

I understand that I may withdraw from the competition at any time, however, in doing so, must return my crown and banner to the state office. Under no circumstances and not for any reason shall I be entitled to a refund in whole or in part of any fees paid. All fees paid to Peterson Productions, Inc and/or the Junior Miss California International Pageant is NOT REFUNDABLE and NOT TRANSFERABLE in full or in part under any circumstances. This includes, but is not limited to entry fees, advertising fees, pageant admission ticket sales fees, guest meal fees and any other fees paid to Peterson Productions, Inc and/or the Junior Miss California International Pageant including, but not limited to, delegates, sponsors, and advertisers.

Contestant will permit Peterson Productions, Inc. and the Junior Miss California International Pageant the right to use contestant's photograph for publicity purposes in connection with the all California International Pageants.

Contestant will permit Peterson Productions, Inc. and the Junior Miss California International Pageant to televise live or by the use of film or videotape any portion or all of the competition.

I further understand that there will be a \$25 fee assessed for any returned check.

Deadlines are determined by the number of entries.

Contestant understands that if selected a winner in her competition, that for one year her professional affairs as said winner will be under the sole management of Peterson Productions, Inc and/or their licensees and that she will not give any written or oral endorsements commercially without the expressed permission of said same. Contestant further acknowledges that all rights for any appearances, endorsements, speaking engagements, acting roles, etc. resulting from winning or being a contestant in the Junior Miss California International Pageant shall belong exclusively to same.
